Rules for overnight camping at Blackthorn Hill

1. Please park all vehicles in main parking area. A vehicle may be used to take supplies to the Activity Area but should be returned to the main parking area when finished unloading.
2. Take your trash out with you when you leave.
3. Quiet hours are 11:00 PM to 6:00 AM.
4. Practice Boy Scouts of America's Leave No Trace principles.
5. Groups with children under the age of 18 years must have at least 2 adults staying with the group.
6. No alcohol or illegal drugs allowed on the property.
7. Blackthorn Hill is a smoke-free area. Smoking is only allowed by persons of legal age inside their vehicles in the main parking area.
8. Organized group camping for up to 40 people is allowed at each campsite.

I have read, understand, and will observe WING's written rules for the reserved site at Blackthorn Hill. I understand that if the site and/or equipment is not left in a reasonable condition after our use, our group's deposit will not be returned. Payment will be due when your reservation is confirmed. If your group cannot make it out on your reserved date you may re-reserve another date or request a refund.

I understand that utilization of the WING's Blackthorn Hill Youth Camp and Nature Preserve property involves a certain degree of risk. I have carefully considered the risk involved and have given consent for myself and/or my group to utilize the property. I understand that utilization of the property is entirely voluntary and requires myself and my group to abide by applicable rules and standards of conduct. I release WING's Blackthorn Hill Youth Camp and Nature Preserve, WING Board Members, the activity coordinators, all employees, volunteers, related parties, or other organizations associated with the activity from any and all claims or liability arising out of the utilization of Blackthorn Hill Youth Camp and Nature Preserve.
